**I. Integrity of Heart and Life**

4. Makes lifestyle choices that lead to physical, emotional, and spiritual health.
5. Demonstrates skill in all verbal and written communication.

## **II. Wholeness of Relationships**

4. Meets regularly with and is accountable to a peer group for growth in discipleship and ministry.
5. Maintains appropriate ethical boundaries in all personal and professional relationships.
6. Shows openness to and works well with people of diverse backgrounds.

7. Makes visible the connectional nature of the Church.
